

Robert Back Photography Model Release for ADULT

For good and valuable consideration, the receipt and legal sufficiency of which is hereby acknowledged,

I _____ (“Model”)

hereby grant Robert Back, Robert Back Photography, the Photographer’s assigns, and those persons acting with the Photographer’s authority and permission, the right to take and create photographs/videos and other still and/or moving images (in all formats) and other graphical depictions incorporating my likeness, in any and all media, whether now known and hereafter created (the “Content”).

I hereby agree that all rights in and to the Content, including the copyright, are and shall remain the sole property of the Photographer, free and clear from any claims by me or anyone acting on my behalf.

The Model’s rights include, but are not limited to, the rights, in perpetuity, to:

Use of Content for purposes related to the promotion of the Model’s Modeling Business, including but not limited to: advertising, portfolios, composite cards, exhibitions, contests, and promotional websites. Model will not sell or otherwise transfer publication rights to any of the Content without Photographer’s written prior consent. Model understands that the Photographer has the moral right to be identified as the author of the Content when copies of the Content are presented to the public, and shall communicate this understanding to publishers, designers, and other third parties that act on the Model’s behalf to create presentation material using the Content. Model agrees that the Content shall not be cropped, altered or distorted in any way when they are used to promote the Model’s Modeling Business. Any watermark or copyright notice that appear, as part of the Content must be left intact.

The Photographer’s rights include, but are not limited to, the rights, in perpetuity, to:

Use, re-use, publish, and re-publish the Content; Alter, modify or otherwise change the Content in any manner the Photographer desires; Combine the Content with textual matter and/or with other pictures and/or media; and, Use the Content for illustration, promotion, art, editorial, advertising, trade, publishing, or any other purpose whatsoever.

I hereby release, discharge, and agree to hold harmless the Photographer, the Photographer’s heirs, legal representatives and assigns, and all persons acting under the Photographer’s authority or those for whom he/she is acting, from any liability by virtue of any use of the Content or any changes or alterations made thereto.

Model hereby affirms that all poses, positions and situations enacted in the Content covered in this release were entered into without force, coercion, or threat whatsoever, and were posed freely by Model with Model’s full consent. Model further agrees to hold blameless and free of all accusation of such force or coercion Photographer, his legal representatives, assigns, and those acting under his/her permission.

I hereby warrant that I am of full legal age and have the right to contact in my own name. I have read the above authorization, release and agreement, prior to its execution, and I am fully familiar with the contents thereof. This release shall be binding upon me and my heirs, legal representatives and assigns and without breach of any prior agreement or applicable law, including but not limited to, prior agreements with modeling and talent agencies.
